Requirements concerning structure and literature:

author (name and surname)

author's affiliation

title of paper in the original language (English/Polish/Russian)

title of paper in English

summary of paper in the original language – min. 200 / max. 250 words

summary of paper in English – min. 200 / max. 250 words

keywords in the original language (at least three)

keywords in English (at least three)

uniform numbering of individual chapters and sub-chapters (1, 1.1, 1.2, etc.)

bibliography in alphabetical order, separately for items in Cyrillic alphabet

Editorial template requirements:

Text length: up to 10–15 pages (1800 characters per page) of formatted manuscript

Font 12 Times New Roman, 1.5 spacing

Individual (standalone) words in titles in English: with capital letters
